PAYMENT SCHEDULE:

A non-refundable \$500 deposit is required to confirm reservation. \$1000 due 90 days prior to departure, remaining balance due 30 days prior to departure.

CANCELLATION POLICY

50% of all monies paid (with the exception of the \$500 non-refundable deposit) are refundable by written request submitted 45 days or more prior to departure date.

25% of all monies paid (with the exception of the \$500 non-refundable deposit) are refundable by written request submitted 44 - 21 days prior to departure date.

No refunds on cancellations submitted 20 days or less prior to departure date.

PRICE POLICY

Package prices are based on US dollars, and do not include airfare. Once Pathfinders Travel Group has received your deposit, you are protected against any package price increases.
